GENERAL TERMS & CONDITION

- 1. The contractor will be permitted to work 7 days in a week round the clock subject to approval of Corporation (WBMDFC).
- 2. No idle labour charges will be entertained at any circumstances.
- 3. The contractor shall procure the best available materials as specified in tender schedule confirming to the relevant BIS standard and all materials to be used in work shall duly be approved by the Engineer in-Charge.
- 4. No mobilisation in advance is admissible under this contract.
- 5. Necessary safety and security measure to the workers are to be given by the tenderer at his own cost.
- 6. 3% of the bill amount shall be kept as retention money which will be converted to security deposit.
- 7. All statutory deduction of taxes as applicable as per rule, will be deducted from the agency's bill.
- 8. In case the work is deliberately suspended for more than half month due to fault of the agency, his security deposit as constituted or earnest money will be forfeited by the Corporation, and the agency will be black listed from participating in tender/quotation for at least 3 years.
- 9. The Agency will be liable to maintain the work at the appropriate service level to the satisfaction of the Engineer-in Charge at his own cost for the entire security period from the date of completion. If any defect/damage is found during the period as mentioned above, the contractor shall make the same good as per contract otherwise, penal action against the Agency will be imposed by the Corporation as deemed fit.
